# **ELIGIBILITY**

Any current member (dues paid by show registration deadline). Prints are allowed but originals are preferred and must follow the McMurray Art League standards. No nudes and/or pieces with religious content. Class work is permitted but must be the artist's original composition and execution (see Standards for details). Work may have been included in a previous MAL show. Note that the juror is looking for the best quality art and may not select your piece(s) to be included in this exhibit. ALL WORK MUST BE FOR SALE.

**Friday, February 11** through **mid-May (TBD), 2022,** at ARC Human Services, 111 W. Pike St., Canonsburg, PA 15317, hours: 7:30-2:30 when the onsite Chicco Baccello coffee shop is open.

# **REGISTRATION**

You may enter up to <u>four</u> pieces of art for the juried show. Please register and pay online or register online and mail a \$20 check made out to McMurray Art League to Jan Pini, 103 Crabtree Ct, Venetia, PA 15367. Please consider donating an extra \$5 or \$10 to the New Screen Fund! A 20% commission will be assessed by the venue. Final online registration date is January 18, 2022. See online MAL Standards document for framing and content requirements. ARC's purchase process includes an image of the artwork so you will need to upload an image (72 dpi is fine) during registration. Please use the naming convention lastname firstinitial title.jpg.

No cards or bin art for this show.

#### **SCREENING OF ART**

Drop off your work Wednesday January 19, 6-7 PM or Thursday, January 20 noon-2 at the McMurray Art League Studio at the McDowell Shops near Atria's. Pick up your work Thursday, January 20, 5-7. Not all work may be accepted by ARC. Jurors will be designating work as either Selected Group A, Selected Group B, or Not Selected. Selected Group A means the work will be hung initially. Selected Group B means work should be delivered to the venue (not at the screening) wrapped in bubble wrap and will be available to be hung should a spot become available. Not Selected indicates work was not selected to be used. Note that artists will be required to sign an Art Consignment Agreement at drop-off which outlines the terms of the exhibit. Attach a tag showing Artist's Name and title to the back of work.

# **DROPOFF OF ART AT VENUE**

Monday, February 7, 10-noon (snow date 2/8, notification by email if needed) at ARC Human Services at 111 W. Pike St., Canonsburg, PA 15317. You may park in the library parking lot, which is a pay lot (you may be able to park briefly without paying to drop off work if you put your flashers on) and enter through the basement door of ARC. The artist will deliver the work to be hung by the show chairs. Works designated as Selected Group B must be bubble-wrapped for storage at ARC until it is needed, with a tag securely fastened to the outside of the wrapping indicating Artist's Name and artwork Title. Consider making a bubble wrap "envelope" using packing tape for ease of use and reuse.

### **PICKUP OF ART**

**Mid-May 2022 (details TBD)** at ARC Human Services at 111 W. Pike St., Canonsburg, PA 15317. Work may be removed earlier by the artist with two days' notice via email to <a href="macrereyd@arcofwashpa.org">mccrereyd@arcofwashpa.org</a>. All work <a href="macrereyd@arcofwashpa.org">must be signed out</a> by you (or someone you designate via email to <a href="macrereyd@arcofwashpa.org">mccrereyd@arcofwashpa.org</a>).

No sitting is needed as the venue will handle sales.

# **SALES**

All work must be for sale. The venue will handle sales and collect and submit sales tax. A 20% commission will be retained by the venue which will mail a check to the artist.
